**MEMORANDUM FOR PETERSON FITNESS AND SPORTS CENTER AND AQUATICS
CENTER PATRONS**

SUBJECT: Policy Memorandum for Peterson Fitness and Sports Center and Aquatics Center

1. This policy memorandum is to outline the current authorized patrons into the Peterson Fitness and Sports Center and Aquatics Center due to the COVID-19 outbreak of 2020.

2. The authorized patrons, based on recommendations by the 21st Medical Group's Public Health team, local guidance, regulations from the Centers for Disease Control, and approval by the Garrison Commander are as follows:

a. Active Duty military members assigned to Peterson Air Force Base (PAFB), Schriever Air Force Base (SAFB), and Cheyenne Mountain Air Force Station (CMAFS) are allowed to lap swim for 45 minutes with a reservation on Mondays, Wednesdays, and Fridays from 0500-1300 and Tuesdays and Thursdays from 1100-1800.

b. Active Duty military members residing in PAFB or SAFB housing that have been on-station for a period of over 14 calendar days without exhibiting COVID-19 symptoms, or coming into contact with someone that has exhibited symptoms or tested positive for the virus.

c. Active Duty military members on temporary orders to PAFB, SAFB, or CMAFS, provided the following:

1 These members have completed a 14-day Restriction of Movement (ROM) period within the local area, without exhibiting any symptoms of COVID-19.

2 These members have provided proof of arrival dates and ROM period to the Fitness Center Superintendent, Fitness Center Manager, or the 21 FSS Sustainment Services leadership.

d. Guard and Reserve members residing in the local area.

1 These members are allowed to enter the Fitness Center Monday through Friday from 0830 to 1530 and 1800 to 2000 and Saturdays from 0700-1700.

2 These members are allowed to lap swim for 45 minutes with a reservation on Tuesdays and Thursdays from 1100-1800.

e. DoD civilians assigned to PAFB, SAFB, or CMAFS.

1 These members are allowed to enter the Fitness Center during normal business hours of Monday through Friday from 0500-2000 and Saturdays from 0700-1700.

2 These members are allowed to lap swim for 45 minutes with a reservation on Mondays and Wednesdays from 0500-1300 and Tuesdays and Thursdays from 1100-1800.

f. Military dependents (age 16 and older, with ID) that live on PAFB, SAFB, or in the local area.

1 These members are allowed to enter the Fitness Center Monday through Friday from 0830 to 1530 and 1800 to 2000 and Saturdays from 0700-1700.

2 These members are allowed to lap swim for 45 minutes with a reservation on Tuesdays and Thursdays from 1100-1800.

g. Retirees that reside in the local area.

1 These members are allowed to enter the Fitness Center Monday through Friday from 0830 to 1530 and 1800 to 2000 and Saturdays from 0700-1700.

2 These members are allowed to lap swim for 45 minutes on reservation basis Tuesday and Thursday 1100-1800.

3. This policy memorandum is in effect immediately until a change to the Health Protection Condition or direction from the Garrison Commander.
